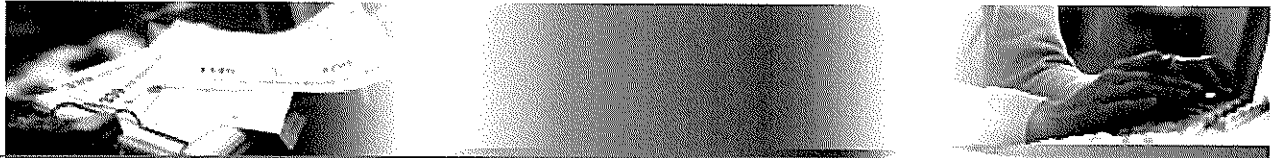

Footnotes

The Company was informed on 30 July 2007 by a substantial shareholder, Fook Yuan International Pte Ltd, that they have entered into a loan with Credit Suisse, under which Fook Yuan was the borrower. Fook Yuan had entered into the following transactions with Credit Suisse:

- "(1) a sale of 25,000,000 ordinary shares of Lereno Bio-Chem Ltd to Credit Suisse;
- (2) a collar transaction, involving a call option granted by Fook Yuan to Credit Suisse relating to 25,000,000 ordinary shares of the Issuer and a put option granted by Credit Suisse to Fook Yuan relating to the same number of shares; and
- (3) another call option granted by Credit Suisse to Fook Yuan over the same number of shares.

The purpose of transactions (1) to (3) was to provide Credit Suisse with collateral for the loan, using the shares. As a result of transaction (1) (the share sale), Fook Yuan's direct interest in the shares of the Issuer was reduced by 25,000,000 shares; as a result of transaction (3) (the call option), Fook Yuan's deemed interest in the shares of the Issuer was increased by the same amount. Fook Yuan's total percentage level in the shares of the Issuer remains unchanged."

The above shareholding percentages under Part IV are calculated by the Company based on the current shareholding capital of 1,323,328,620 shares.
