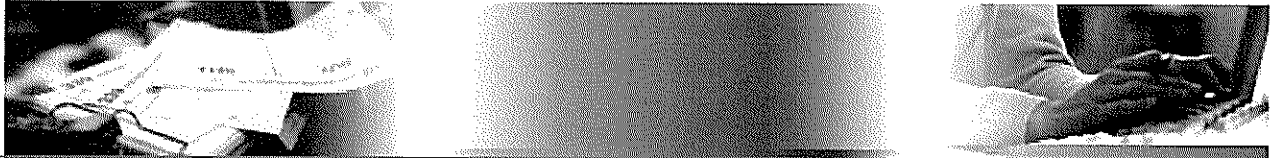

The difference between the above shareholding percentage of 10.07% and the shareholding percentage of 10.42% announced on 14 June 2007 was due to the listing and quotation of 35,000,000 new ordinary shares of the company pursuant to the subscription agreement dated 14 June 2007 entered into between the Company and Mr Soh Eng Bee (refer to our Announcement No. 00028 on 24 July 2007) and the impact of warrant conversions since then.
